Spotlight on House-Passed Bills

Speaker Ryan's First 12 Months Produce Mixed Legislative Results

During his first 12 months as House speaker, Rep. Paul Ryan delivered legislative results that reflect some mainstream Republican priorities but fall far short of the wide-ranging policy manifesto he is promoting as a rationale for voters to support GOP congressional candidates on Nov. 8.

The document, "A Better Way," lays out a vision of GOP governance starting as early as 2017, as well as a platform for the 2020 presidential bid many expect Ryan, a nine-term Wisconsin congressman, to mount if Democrat Hillary Rodham Clinton is elected this year. But amid rising public distrust of the veracity of career politicians, it also invites comparisons between Ryan's words and deeds since he was elected as speaker on Oct. 29, 2015. On that score, his accomplishments are limited.

The House has voted approval of 90 major bills on Ryan's watch, all sponsored by Republicans because they are the chamber's majority party. These bills generally cater to the party's business wing and donor class, while producing few if any accomplishments for fiscal conservatives wary of debt, tea-partiers who want a replacement health law and Trumpites in step with their presidential candidate's stands on trade and immigration.

Thirty-five of the measures, or nearly 40 percent, seek to repeal or block financial and environmental regulations and other federal rules seen as drags on economic growth and personal freedoms by interest groups such as the Chamber of Commerce and mega-donors including Charles and David Koch.

In part, the deregulatory blitz has targeted the Securities and Exchange Commission, Environmental Protection Agency and Consumer Financial Protection Bureau, along with administration policies for overseeing Wall Street, enforcing environmental laws, addressing climate change and shifting energy production from fossil to renewable fuels.

But fiscal reformers watched in vain as the speaker, hemmed in by the hard-right Freedom Caucus, failed in the past 12 months to bring to the House floor a congressional budget resolution or any other measure that would slow the growth of federal debt, overhaul the tax code or take a stab at Medicare, Social Security, Medicaid and other entitlement programs.

To the contrary, the House under Ryan voted to expand Medicare and Medicaid in order to fund programs for the mentally ill, and passed bills that would increase deficits by \$622 billion over 10 years by permanently extending tax breaks for businesses, families and others; \$32.7 billion over 10 years by enlarging deductions for unreimbursed medical expenses and \$1 billion over 10 years by changing rules governing employee stock options.

The speaker's office did not respond to requests for comment on this story.

In addition to the 35 deregulation measures, the Ryan-passed agenda was led by eight health bills (mainly concerning opioid-heroin addiction and the Affordable Care Act); eight massive budget bills to fund agencies; six attempts to roll back the Iran nuclear deal and four legislative assaults on the Internal Revenue Service and its civil servants. Numerous subject areas recorded two passed bills, while several others – including immigration, trade, infrastructure and abortion – were substantially the focus of only one House-passed measure on Ryan's watch.

The following document lists all measures passed by the Republican-led House since the speaker's swearing-in Oct. 29, 2015, except for non-controversial bills from the Suspension Calendar. Asterisks mark the deregulation bills. The four bills passed under Ryan that cut taxes while expanding deficits are marked by roll numbers 703 and 705 in 2015 and 502 and 544 in 2016.
